AN ORDINANCE AMENDING, ADDING, AND REMOVING FEES AND FINES OF TITLE 4 FEES AND FINES OF THE CODE OF ORDINANCES OF THE CITY OF COLLINSVILLE, ILLINOIS

WHEREAS, the City Council of the City of Collinsville (hereinafter "the City") recognizes the need to provide for the safety, health and welfare of Collinsville's citizens by providing for a uniform set of fees and fines within the City's Municipal Code;

WHEREAS, the Collinsville is a home rule municipality under the Constitution and laws of the State of Illinois, and hence is granted powers and authorities as provided therefore, including the setting of fees and fines as related in this Ordinance;

WHEREAS, the Corporate Authorities of the City have determined in the exercise of their authority pursuant to the Illinois Municipal Code, and the court opinions provided therefore, including but not limited to 65 ILCS 5/1-2-1, and that it is in the best interests of the public health, safety and welfare to establish uniform fines and penalties for violations the Collinsville Municipal Code; and

WHEREAS, the Corporate Authorities have determined that it is in the best interest of its residents and businesses to reassess services fees to ensure each fee is set at a level that recovers the City's costs, and to reorganize Title 4 based on the type of service being provided.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF COLLINSVILLE, ILLINOIS, that the Collinsville Municipal Code is amended as follows:

<u>Section 1</u>: Upon the effectiveness of this Ordinance and with no lapse in between, Title 4 (Fees and Fines) of the Collinsville Municipal Code, is hereby amended so as to read in its entirety as follows:

Title 4 – FEES AND FINES

Additional fees that may apply include: 1) excavations into the street which would add approximately \$700.00 to each tap for proper backfill and street repairs; or 2) bores under the street would add approximately \$500.00 to each tap for the additional labor and boring unit time. Tap size larger than 1" would increase the

tap-on fee. Additional fees may apply which will be determined by the Public Works Department Director.

Any person, firm or corporation who shall be found guilty of violating any provision of the Registration for all Motel/hotel Guest Chapter. – Not more than \$750.00 for each offense (5.76.040)

Any person, firm or corporation who shall be found guilty of violating any provision of the Registration for all Motel/hotel Guest Chapter for a second time within a twelve (12) month period. – Not less than \$750.00 per offense (5.76.040)

8. Raffle License Fine

Any person found guilty of violating any provision of the Raffle License Chapter. – Not more than \$750.00 per offense (5.90.190)

18. Unlawful Possession, delivery, or manufacture of cannabis

Any person violating the Unlawful Possession, delivery or manufacture of cannabis Section. – Not more than \$750.00 per offense (9.16.110)

19. Unlawful Possession of Look-alike Substances

Any person violating the Unlawful Possession of look-alike substances Section. – Not more than \$750.00 per offense (9.16.120)

20. Unlawful Sale of Tobacco

A violation of any provision of the Unlawful Sale of Tobacco Section. – Not more than \$750.00 per offense (9.16.140)

21. Unlawful Sale of Tobacco Accessories

A violation of any provision of the Unlawful Sale of Tobacco Accessories Section. – Not more than \$750.00 per offense (9.16.150)

22. Unlawful use or sale of intoxicating compounds

Any person violating the Unlawful use or sale of intoxicating Compounds Section. – Not more than \$750.00 per offense (9.16.160)

23. Display of Adult Magazines

A violation of any provision of the Display of Adult Magazines Section. – Not more than \$750.00 per offense (9.16.180)

24. Delivery of drug paraphernalia to a Minor Fine

Any person eighteen (18) years of age or over who violates this chapter by delivering drug paraphernalia to an individual under eighteen (18) years of age who is at least three (3) years junior to such person is guilty of a special offense and upon conviction. – Not less than \$750.00 (9.18.040)

25. Drug Paraphernalia

Any person violating the Drug Paraphernalia Chapter as a first offense. – Not less than \$350.00 plus court costs (9.18.080)

31. Unlawful Visitation Interference

A violation of any provision of the Unlawful Visitation Interference Section. – Not more than \$750.00 per offense (9.32.130)

32. Harboring a Runaway

A violation of any provision of the Harboring a Runaway Section. – Not more than \$750.00 per offense (9.32.140)

33. Contributing to dependency or neglect of a child

A violation of any provision of the Contributing to dependency or Neglect of a Child Section. – Not more than \$750.00 per offense (9.32.150)

34. Contributing to delinquency of a child

A violation of any provision of the delinquency of a Child Section. – Not more than \$750.00 per offense (9.32.160)

35. Order of Protection

A violation of any provision of the Order of Protection section. – Not more than \$750.00 per offense (9.32.170)

36. Tattoo Parlors

A person convicted of violating the Tattoo Parlors Section. – Not more than \$750.00 per offense (9.32.180)

37. Housing Discrimination Fine

Any person who violates any provisions of the Housing Discrimination Chapter. – Not more than \$750.00 per offense. (9.36.170)

38. Tobacco and Tabacco Paraphernalia

A violation of any provision of the Tobacco and Tobacco Paraphernalia Section as a first offense. – \$75.00 plus court costs (9.32.200)

A violation of any provision of the Tobacco and Tobacco Paraphernalia Section as a second offense. – \$150.00 plus court costs (9.32.200)

A violation of any provision of the Tobacco and Tobacco Paraphernalia Section as a third offense. – \$750.00 plus court costs (9.32.200)

39. Graffiti - Criminal Penalty

Any violation of the Graffiti Chapter. – Not to exceed \$1,000.00 (9.40.080)

A person convicted of a violation of the Commercial Building Code. – Not less than \$75.00 and not more than \$750.00 per offense (15.04.015)

49. Construction Code Fine

Any person, firm or corporation who violates, disobeys, omits, neglects or refuses to comply with or who resists the enforcement of any of the provisions of the City Adopted Construction Codes. – Not more than \$750.00 per offense (15.04.110)

51. Demolition Permit Fine

Any person, firm, corporation or entity guilty of violating any provision of the Demolition Permit Chapter. – Not more than \$750.00 per offense (15.28.050)

52. Vacant Structure Registration Program Violation

Any person found to be in violation of any provision of the Vacant Structure Program Chapter. – General Penalty (15.50.150)

53. Boarding of Building Fines

Any person, firm, corporation, agent, association, or employee who violates any provision of the Boarding of Building Chapter. – General Penalty (15.60.110)

50. Failure to Address Subdivision Improvements

Failure to take the necessary remedial action within 30 calendar days. – Not More than \$500.00, with an additional \$500.00 every 14-calendar days between the initial 30 days during which the necessary repairs/maintained deadline. (16.16.160)

51. Private central sewage systems maintenance responsibilities

Failure of the subdivider to discharge his operational/maintenance responsibilities. – \$500.00 per day (16.16.230)

52. Change in Property Ownership and/or Contractor During Land Development Activities Failure to comply with the provisions of the Change in Property Ownership and/or contractor during land develop activities. – General Penalty (16.22.040)

53. Adult Entertainment Business Zoning Fine

Any licensee, operator, employee, or other person who violates any of the provisions of the Adult Entertainment Business Section. – General Penalty (17.054.030)

54. Truck Tractors and Trailers

Any person who is convicted of a violation of the Parking & Storage, Enforcement Section. – Not more than \$750.00 plus costs - each day shall be considered a separate offense. (17.088.290)

55. Zoning Violations and Penalties

Fines for zoning violations. – Not less than \$75.00 per offense each day (17.140.020)

56. Snipe Signs

Each sign shall be considered a separate violation and shall carry a penalty for each. – First violation - \$100.00, Second Violation \$200.00, Third and subsequent violations - \$300.00 (17.190.040)

57. Signage – General Provisions

Any person who is convicted of a violation of the Signage General Provisions. – Not less than \$50.00 nor more than \$750.00, plus costs. Each day that a violation continues shall be considered a separate offense (17.190.050)

58. Telecommunication Towers Violation

Any person violating any provision of the Telecommunication Towers Chapter. – Not more than \$750.00 for each offense (17.920.100)

59. Change in Property Ownership and/or Contractor During Land Development Activities Failure to comply with the provisions of the Change in Property Ownership and/or contractor during land develop activities. – General Penalty (18.02.050)

60. Flood Damage Prevention

Any person violating any of the provisions Flood Damage Prevention Chapter. – Not less than \$250.00 or more than \$750.00 for each offense (18.06.130)

61. Business License and Registration Fine

Any person, firm or corporation who shall be found guilty of violating any provision of Business Licenses Generally shall, for each offense, be fined a sum of not more than \$750.00.

Any person, firm or corporation who shall be found guilty of violating any provision of Business Licenses Generally for a second time within a twelve (12) month period, shall, for each offense, be fined a sum of not less than \$750.00.

Sec. 4.01.030 -- Outstanding monies due to the City.

Any permit, license, program, or utility, or service provided by the City may be denied if the person has outstanding fines, fees, taxes, or money due the City and has failed to pay the fines, fees, taxes or money due. The denial of the permit, license, program, utility or service shall not apply to emergency services relating to the public health, welfare or safety. The denial of permit, license, program, utility or service shall not apply to any property with outstanding real property taxes. The person requesting the permit, license or fee, utility, or service may appeal a denial to the City Manager. The appeal shall be in the manner as an appeal of a denial of business license found in Section 5.04.150 (Hearings), of this Municipal Code.

<u>Section 2.</u> In the event any section or provision of this Ordinance shall be held unconstitutional or invalid by any Court, in whole or in part, such holding shall not affect the validity of this Ordinance or any remaining part of this Ordinance, other than the part held unconstitutional or invalid.

<u>Section 3.</u> All ordinances, or parts thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of their inconsistencies.

Section 4. Nothing contained herein shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other ordinance of the City or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof, unless expressly set forth herein.

<u>Section 5.</u> This Ordinance is effective upon its passage by the City Council, approval by the Mayor, and publication according to law.
