

ORDINANCE NO. _____

**AN ORDINANCE AUTHORIZING THE JURISDICTIONAL TRANSFER
OF A CERTAIN HIGHWAY FROM ILLINOIS DEPARTMENT OF
TRANSPORTATION TO THE CITY OF COLLINSVILLE**

(Ramada Boulevard from east edge of pavement of north bound IL 157 easterly 0.03 miles)

WHEREAS, the City of Collinsville (the “City”) is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970;

WHEREAS, the intergovernmental Cooperation Act, 5 ILCS 220/1, et seq., authorizes cooperative agreements between the State of Illinois and Illinois units of local government;

WHEREAS, the City and the Illinois Department of Transportation (“IDOT”) agreed to transfer IDOT’s jurisdiction of Ramada Boulevard from the east edge of pavement of northbound IL 157 easterly 0.03 miles, in its entirety, to the City pursuant to the terms of the Jurisdictional Transfer Agreement attached hereto and incorporated herein as Exhibit A (the “Agreement”);

WHEREAS, the City’s corporate authorities find that approving the Agreement is in the City’s best interests for the protection of public health, safety, and welfare; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF COLLINSVILLE, ILLINOIS, as follows:

SECTION 1: The recitals to this ordinance are adopted and incorporated herein as Section One to this Ordinance.

SECTION 2: The City’s corporate authorities approve, authorize, and direct the Mayor to execute the Agreement attached hereto and incorporated herein as Exhibit A.

SECTION 3: The City’s corporate authorities approve, authorize, and accept the jurisdictional transfer of approximately 0.03 miles of Ramada Boulevard from the east edge of pavement of north bound IL 157 easterly 0.03 miles into the City’s street system.

SECTION 4: This ordinance shall be in full force and effect from and after its passage and approval as provided in law.
