

**PLANNING COMMISSION

07/09/2026**

Chairman Bechtle calls the meeting to order with the following member present and answering roll call: Bechtle, Jackstadt, Siekmann, Tolliver, Dow.

Also Present: Community Development Director Taylor, Senior Planner Rice, and Recording Secretary Robinson.

DISCUSSION

Community Development Director Taylor advises that he will be speaking about the data center text amendment. He further states the research he has done since our last meeting. He speaks about possible location options and asks for feedback. He advises Staff is proposing subdividing the data centers into three categories Micro, Standard, and Major Data centers, mimicking the City of St Louis.

Taylor then discusses location permitting. Staff is proposing all data centers, depending on sizes and locations will require special use permits, requiring them to go to Planning Commission. He then presents a map showing the location of the permitted districts.

Jackstadt asks that the size limitation of the data centers be taken into consideration, after learning there is no cap on the size allowances.

Community Development Director Taylor discusses the items the City and Commission cannot regulate. He then advises the special use permit application requirements, including third party reports, agreement with electric service provider, site plan and necessary documents demonstrating compliance and decommissioning plan. Taylor further details some of the proposed regulation.
