Respondent to pay and Petitioner to accept the sum of \$33,139.13 in full and final settlement of all issues arising out of the accidental injury sustained on or about 08/29/2024 and any aggravating incidents occurring thereafter in Petitioner's employment with Respondent to the date of the signing of this contract with regard to Petitioner's [REDACTED] and is to be paid in a lump sum upon approval of this contract. Disputes exist between the parties as to the nature and extent of permanent disability and future medical treatment, if any. It is the purpose of this contract to affect a full and final settlement of all issues existing between the parties under the Illinois Workers' Compensation Act including, but not limited to, the right of either party to review or reopen this case under Sections 8(a) and 19(h). This contract does not, however, extinguish any rights that the Respondent may have under the Act and in accordance with the provisions of Section 5 (820 ILCS 305/5). Petitioner asserts that he is not currently a Medicare Beneficiary, has not applied for any Social Security Disability Benefits or other benefits to which he might be entitled to Medicare or Medicaid benefits, that none of his medical bills in connection with care and treatment for this event were submitted to Medicare/Medicaid for payment and that he is not likely to become a Medicare/Medicaid recipient within the next 30 months. Petitioner also asserts that he is not currently undergoing any care or treatment for the injuries he sustained on 08/29/2024 and that no further treatment has been recommended to him by any physician or other medical provider. The parties acknowledge and agree that they have considered the future interest of Medicare/Medicaid in the resolution of this case and that they find that no provision needs to be made for the establishment of any Medicare Set Aside Trust Fund.
