#### G. PUBLIC HEARING:

 Public hearing on items COA 25-03 & COA 25-04 were presented to the commission and public, with the commission opting to approve the following:

- o COA 25-03 (Kennedy House 401 E. Church Street):
  - HPC voted unanimous approval for the balcony demolition and reconstruction at 401 E. Church Street, with conditions that the six (6) columns supporting the structure shall be changed to appear more ornate in design. The applicant will return an updated rendering to staff to be approved.
- O COA 25-04 (Blum House 414 W. Main Street):
  - HPC voted 6 "ayes" to 1 "abstention" on the project. Lois Metzger noted that she was on the library board, so abstained from voting either way. The approval consisted of conditions that allowed staff to approve minor changes that were made to the building in regard to safety regulations. Paul Welsh from the Library Board gave a small history of the house to clear up any discrepancies.
