Senior Planner Caitline Rice advised this amendment is a City-initiated request to allow for native plantings. She advised the intent of this amendment is to provide clear and simple guidelines to ensure native planting areas are intentional, planned, and maintained.

She highlighted the proposed guidelines regarding the planting of native grasses, wildflowers, ferns, shrubs, etc:

Turf grass, noxious weeds and e=invasive species shall be removed prior to seeding or planting of native plants.

Location of native plantings cannot constitute a hazard to the public.

Native plants cannot encroach into neighbors property or upon sidewalks and streets.

Areas with native plants must be well maintained and defined with appropriate borders.

Burn permits are required prior to ecological burning.

Ms. Rice advised a zoning analysis was done in which all criteria was met and the Planning Commission recommends approval.

2. Ordinance Amending Title 17 (Zoning) of the Code of Ordinances as it Relates to Swimming Pools (Noncommercial)

Ms. Rice spoke of a previous variance regarding property line setbacks for an above ground swimming pool. This proposed amendment is to allow for a 5' setback from the side and rear yard property lines for swimming pools and define appropriate fence barrier requirements for above ground pools based on Building Codes.

She explained that the current Zoning Code requires a separate fence barrier for above ground pools while the Building Code permits the wall of an above ground pool to count toward the barrier if it is at least 48' tall. This amendment would remove fence barrier requirements from the Zoning Code and rely on Building Code interpretations.

3. Ordinance Amending Title 17 (Zoning) of the Code of Ordinances as it Relates to Signage Requirements

Overview by Joseph Williamson, Associate Planner, who advised this is an amendment regarding sign requirements. He spoke of the goals achieved by the proposed amendments to include:

Replacement of signs in existing cabinets or mounts may be switched out without requiring another permit.

Regulations to maintain abandoned signs.

Define material requirements for permanent signage.

Define setbacks for freestanding signs.

Codify Sign Zone 4.

He identified amendments related to Sign Zone 4 to include required materials to be used. The amendment specifies a durable, weatherproof material such as acrylic, metal, or PVC material to be used on all permanent signage.

The proposed amendment will also define and prohibit abandoned signage. Signs will be identified as abandoned 90 days after the closing of a business or establishment. The property owner will have 30 days to remedy the abandoned sign by replacing it with a plain panel.

He advised the amendment would also allow for one-for-one sign panel replacements. This replacement process will not require a permit as long as the cabinet or mount was previously approved and legally conforming. This process will consist of a panel replacement only.

Mr. Williamson advised this amendment will include sight distance triangle setbacks for freestanding graphics.

Lastly, he advised this amendment is in comparison with those of surrounding communities and the Planning Commission recommends approval.

4. Ordinance Rezoning Certain Real Property Owned by the City of Collinsville to Planned "CP-1" Commercial Park District (400 Pine Lake Road)

Community Development Director Travis Taylor advised this Ordinance would amend an existing planned Commercial Park District at 400 Pine Lake Rd. to allow for deviations pertaining to the future site of Fire Station 2. He outlined the listed deviations to include:

Landscape islands within the parking lot

Minimal parking requirements

Setbacks

He described the parcel as being over 1 acre in size. He displayed an aerial view of the property, site and landscape plans, site photos, as well as Zoning and Future Land Use maps. He advised the City is working with ArchImages for the design of the new Fire Station.

He elaborated on the deviations:

Removal of required landscape islands within the parking lot to allow for additional space for outdoor training exercises and maneuvering of large apparatus.

Reducing the number of parking spaces from 60 to 41 spaces which is more than enough for on-duty staff.

Reducing the side setbacks from 50 feet to 20 feet on the east side.

Director Taylor advised a zoning analysis was done in which all criteria was met.

Councilman Fuhrmann inquired as to why the City is wanting to rezone the property with deviations if the public body has yet to approve the new Fire Station. Director Taylor clarified that rezoning the parcel does not approve the building. Mayor Stehman advised the building plan will come back to Council for approval later on.

Councilman Fuhrmann inquired of the need for 41 parking spaces since only 4-5 are on a shift at any given time. Chief Bailot advised 41 parking spaces is more than enough for employees but additional parking may be necessary to host training events for the regional as well as concrete surface for heavy vehicles to be maneuvered. Mayor Stehman indicated that other communities come to this area for training. Councilman Fuhrmann inquired of current training being offered to which Chief Bailot advised the Collinsville Fire Department holds their training at Fire Station 1 now but when additional space is needed, they take their training off site to the Gateway Convention Center, if available. When the Gateway Center is not available, they host training elsewhere, such as the VFW.

Ordinance Authorizing the Mayor to Execute an Agreement with GRP
Wegman in Relation to the Installation of Solar Panels at the Wastewater
Treatment Plant in the City of Collinsville, Illinois

Troy Turner, Public Works Director, advised this Ordinance would authorize an agreement with GRP Wegman for the installation of a solar energy system at the Wastewater Treatment Plant (WWTP) in the amount of \$6,472,846. He advised the estimated offset of incentives is \$4,913,771 (76% of the total project cost) from energy credits, rebate and federal tax credit. He advised the WWTP is the largest energy consumption City facility. This project is estimated to offset 103% of the kWh usages.

The estimated payback time frame is 5.9 years. Staff recommends proceeding with the project.

Police Chief Brett Boerm indicated the City recently became aware of an outdated Ordinance still on the books which does not align with State or Federal laws. He advised Section 9.28.010 of the City's Code prohibits mace (pepper spray) for self defense and criminalizes the possession of firearms in places that sell liquor. At this time, there is no longer a State or Federal law prohibiting such; and therefore, staff is recommending repealing Section 9.28.010 regarding unlawful use of weapons.

#### ADDRESSING THE COUNCIL DURING SPEAKERS FROM THE FLOOR

Below are the rules for input during City Council meetings as set out in Ordinance No. 4765 entitled "Ordinance Governing Speakers From the Floor During Meetings of the City Council and the Commission, Boards, and Sub-Bodies of Collinsville, Illinois". Speakers may address the Council during the time designated as Speakers From the Floor on the agenda.

- RULE 1: Speakers shall be allowed only during "Speakers from the Floor," or at any other time if requested by a member of the City Council.
- RULE 2: Input must relate to a matter under the authority of the City of Collinsville.
- RULE 3: Upon request by the meeting Chairman for speakers from the floor, a prospective speaker shall express the desire to speak, be recognized by the meeting Chairman, approach the designated podium, and state their name and general subject matter to which they will address the City Council.
- RULE 4: After establishing their identity, prospective speakers shall immediately address only the City Council.
- RULE 5: Each speaker is limited to four (4) minutes to address the City Council. No extensions will be granted and no time shall be compensated to the speaker resulting from interruptions by or discussion with the City Council, City Manager, or any other City officer or employee.
- RULE 6: Speakers shall address only the City Council collectively or its members individually. Speakers shall speak to issues and shall refrain from personal attacks on City appointed officials and employees. Speakers may not address issues related to pending litigation in which the City or its subsidiary bodies, officers, agents, employees, boards or commissions is a party.
- RULE 7: Speakers shall not be permitted to advertise, solicit, request, urge, summon, or cajole the City Council or the general public, except as otherwise provided for herein, with regard to any products, goods, services, information, gains, losses, advantages, consequences, or any other similar matter, notwithstanding that there may or may not be any pecuniary, monetary, financial or property gain, loss, or benefit to the speaker or any other person or entity.
- RULE 8: Speakers shall act and speak with decorum and conform to conventional social manners in speech, writing, dress, and behavior. The audience shall refrain from conduct that disrupts the meeting in any way such as clapping, booing, loud talking or outbursts. A speaker may be immediately terminated at the meeting Chairman's discretion.
- RULE 9: Determination of breaches of this Ordinance shall be made by the meeting Chairman. The meeting Chairman customarily will warn the speaker or members of the audience of inappropriate behavior through one warning use of the gavel. Subsequent inappropriate behavior shall result in the immediate removal of the responsible parties at the discretion of the meeting Chairman.
