ITEM:	Ordinance Authorizing the Mayor to Accept Proposal for Audit Services
STRATEGIC PLAN GOAL:	Goal #7 – Financial Stewardship and Sustainability

BACKGROUND:

After discussion at the November 14th meeting, the City Council directed staff to reconsider its recommendation to retain CJ Schlosser & Company LLC as auditor. The City of Collinsville has not adopted a policy of mandatory auditor rotation. However, the City has enjoyed a long, twenty-year relationship with CJ Schlosser and it would be prudent to change auditors at this time.

The Finance Department recommends Hochschild Bloom and Company LLP as the new auditor for the next four years. A four-year engagement will allow the City and the auditor to develop an efficient and effective process, while aligning the next request for proposals (RFP) with the City's budget cycle.

He is widely recognized as the local expert on GFOA's Certificate of Achievement Program.

This is the first time Hochschild Bloom has submitted a proposal for the City of Collinsville. Attracting a firm of this caliber reflects well on the City. The transition is expected to go smoothly and result in a higher level of professionalism within the organization.
